Mr. Pooch moved, seconded by Mr. Bias to approve and sign the warrants (17140 – 17159) and EFTs submitted for payment by the Fiscal Officer. Vote: all ayes

Mr. Pooch moved, seconded by Mr. Bias to approve the financial reports submitted by the Fiscal Officer. Vote: all ayes

Keith Kreager, Erie County Rural Water:

Mr. Kreager informed the Trustees of the 25% reduction in water tap fees during the 'County Fair Months'.

Jim Neill: Road & Cemetery Department (not in attendance)

Mr. Neill reported that the crack sealing is near completion and the chip-and-tar will follow in the near future.

Mr. Neill indicated the industrial park will be micro-sealed in late August.

Mr. Neill reported that Matt Studer continues with the roadside mowing and is in the second week of mowing. He should be completed with the remainder of the township in the next few weeks.

Tom Johnson: Fire Chief:

Chief Johnson presented vacation a request for Dan Strayer (24 hours). Mr. Pooch moved, seconded by Mr. Bias to approve the requests. Vote: all ayes

Chief Johnson reported that Firefighter Dean Gasser will be off work until September and the Chief will help cover the open shifts to help reduce overtime.

Mr. Bias presented Resolution 2018-09. A Resolution to submit to the Board of Election the 3.95 Mill levy for the Fire Department. Mr. Pooch moved, seconded by Mr. Bias to approve the submission of the 3.95 Mill levy to the Board of Election. Roll Call Vote: Mr. Pooch – aye, Mr. Bias – aye.

Chief Johnson discussed the success of the chicken barbeque and the great response from the community. He thanked all that assisted and reported there were 865 chickens sold.

Chief Johnson presented the bids for the Fire Department boat (#162). He has received 7 bids. Mr. Johnson and Mr. Schaeffer discussed the updated zoning book.

Mr. Schaeffer discussed the violations and issues with the Cody property. He also presented proposed actions to be taken in light of the continued violations.
