Mr. Keith Kreager was at the meeting. He said everything seems to be ok in Crystal Rock so far this year. He also asked if there were any Rural Water questions. He would like to remain our representative. We need to see when he was appointed and for how long.

Mr. Tom Johnson, our zoning inspector, mentioned that there is a house in Crystal Rock with issues on Sandusky & Maple Ave. This house cannot be occupied until the Health Department gives its approval. Tom mentioned that the house in Crystal Rock that burned is still under investigation.

Mr. Johnson has some concerns with the zoning book not addressing some issues he has regarding accessory buildings.

Chief Keimer gave his report. He said that we have the hardware for our phones is up and running for our change to Buckeye Cable.

Chief presented his monthly and annual reports to the Trustees.

The Fire Department needs some new hoses. Tom had no word on the FEMA Grant. The Trustees asked Chief Keimer about our staffing issues. He said that the officers are not in favor of hiring part time people.

Mr. Riesterer mentioned that our contract with Huron for dispatching will run until the end of February, 2011. The Sheriff Department will begin our dispatching on March 1, 2011.

Mr. Bias moved, seconded by Mr. Pooch to approve the purchase of misc. hoses for the Fire Department from Fire Safety Services for a cost not to exceed \$2000. Vote: all ayes.

Mr. Jim Neill gave his Road and Cemetery Report. We received an update from the Health Department on Crystal Rock and Whites Landing. The Trustees discussed the purchase of a crack sealer and also that we will then get rid of our old one.

Mr. Bias moved, seconded by Mr. Pooch to pass Resolution 2011-01, entering into a joint purchasing contract between Groton Township, Oxford Township and Margaretta Township to purchase a crack sealing machine for a cost of \$29455.92, to be divided 3 ways. Roll call vote: Mr. Pooch- yes, Mr. Bias-yes and Mr. Riesterer-yes.

The Trustees discussed upcoming levy issue, and raises for 2011.

The Trustees will start their search for a new Fire Chief, due to Chief Keimer planning on retiring this year.

Fiscal Officer, Mary Ann Lindsley mentioned to Chief Keimer and Jim Neill that Tom Welsch from OTARMA will be here on Monday to go over some things regarding our casualty insurance renewal in April.

Mr. Bias moved, seconded by Mr. Pooch to adjourn. Vote: all ayes. The meeting adjourned at 9:10 p.m.
