We had a request for some records pertaining to property on Maple Ave. Mr. Johnson is trying to get together anything he can find. He has asked Tracy Keller to bring up records that she has.

Mr. Bias moved, seconded by Mr. Riesterer to pass Resolution 2013-16: to have the Erie County Engineer issue hauling permits for Margaretta Township. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Bias to approve longevity pay for non-union full time employees to be \$50/year for years 1-15 of full time employment and \$60/year for 16 + years of full-time employment. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Riesterer to give the Assistant Chief holiday pay for 112 hours. Vote: all ayes.
