Board Items:

Mr. Day discussed the healthcare options due to the 21.93% increase in premiums for the next year. Mr. Day will contact Chris Kane with Assured Partners for clarification on issues.

Mr. Riesterer presented vacation requests for Dan Maloney (72 hours and 24 hours). Mr. Bias moved, seconded by Mr. Pooch to approve the submitted vacation requests. Vote: all ayes.

Mr. Day presented Resolution 2020-10 – A resolution to proceed to submit to the Erie County Board of Elections the .50 mill Road & Bridge Levy to be placed on the November 2020 ballot. Mr. Bias moved, seconded by Mr. Pooch to approve Resolution 2020-10. Roll call vote: Mr. Pooch – yes; Mr. Bias – yes; Mr. Riesterer – yes.

Mr. Day presented Resolution 2020-11 – A resolution to proceed to submit to the Erie County Board of Elections the 2.0 mill Fire & Apparatus Levy to be placed on the November 2020 ballot.
