

The Margaretta Township Trustees met in regular session on August 18, 2016 at 7 p.m.

Present were Mr. Bias, Mr. Riesterer and Mr. Pooch.

Mr. Bias moved, seconded by Mr. Riesterer to approve the minutes from the August 4, 2016 meet, as presented by Fiscal Officer, Mary Ann Lindsley. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Bias to approve and sign warrants #15382-15409 and eft's that were submitted by the Fiscal Officer for payment. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Riesterer to accept the financial reports that were submitted by the Fiscal Officer. Vote: all ayes.

Mr. James Neill gave his Road and Cemetery report.

Mr. Neill said he met with Zack from Strawser Construction about Industrial Park. Jim had quotes from Shrearer Equipment for a new gator from Deere & Company. Jim said that Erie Materials would like to do Vickery Road as a test, with us purchasing the materials.

We have completed the second round of road mowing.

Mr. Riesterer moved, seconded by Mr. Bias to approve the vacation request for Matt Studer for September 6, 7, 8, & 9, 2016. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Riesterer to purchase materials from Erie Material to seal coat Vickery Road. Total cost of materials is \$11,860.50. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Bias to purchase 2 new gators from Deere & Co. under state bid of \$8167.02 each with trade in for Park gator of \$3500 and cemetery gator of \$4500 . The total Park cost to be \$4667.02 and the total Cemetery cost to be \$3667.02. Vote: all ayes.

Chief Johnson gave his Fire Department report.

Chief gave a radio tower update.

Our current contract with Bay View ends on September 1, 2016. We have not heard back from them.

Mr. Bias moved, seconded by Mr. Riesterer to approve the vacation request for Keith Killingsworth for Sept. 3, Nov. 27, and Dec. 2, 4, & 24, 2016. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Riesterer to send Chief Johnson and Dan Strayer to Firelands Supervisor Training on Wed. Aug. 31, 2016 from 7:30-9:30. The cost will be \$65/each. Vote: all ayes.

Mr. Bias gave a brief Park report. They have plans to put dirt on some of the fields.

Mr. Riesterer moved, seconded by Mr. Bias to adjourn. Vote: all ayes.
