Fiscal Officer, Mary Ann Lindsley mentioned that our medical insurance renewal is at 2.7% increase and our life insurance through Fort Dearborn will remain the same with no change in premium. The trustees said that we will go ahead and get quotes even though this was a good renewal. Mary Ann said that we will have forms for everyone to fill out in order to quote. She will get them here by tomorrow so we can get this done.
