Mr. Pooch moved, seconded by Mr. Bias to accept the financial reports that were presented by Fiscal Officer, Mary Ann Lindsiey. Vote: all ayes.

Mr. Jim Neill gave his Cemetery and Road report. Jim had his proposed budger estimate for the years. Mr. Neill also went over his proposed 2011 roads for maintenance. He asked the trustees to look it over and said that we need to have it submitted to the County by March 25, 2011. Jim had several drainage issues that he went over with the trustees. There is an issue with the Joan Crawford property on Gardvell that the trustees said should be addressed by the county. The trustees said that in the meantime we'll see what we can do to help this situation. They will contact Ken Fortney from the county to take care of the problem. Jim said that there is a problem on Miller Road west of Bardshar and that he feels the ditch needs to be cleaned. We will check into getting a ditch petition.

Mr. Pooch moved, seconded by Mr. Bias to pass Resolution 2011-07, to purchase a 2012 7400 SFA 4x2 (SA525) International Truck from Miami Valley Int'l Trucks, Cincinnati, Oh.o, under state bid for a cost of \$71,892.00. Roll Call Vote: Mr. Pooch-yes, Mr. Bias-yes and Mr. Riesterer-yes

Mr. Bias moved, seconded by Mr. Pooch to pass Resolution 2011-08 for the purchase and installation of a snow plow, salt spreader, dump body, hoist, hydraulics, fenders, tarp, lights and hitch for a cost of \$54,136.51 under state bid from Newell Equipment, Galion, Ohio. Roll Call Vote: Mr. Pooch-yes, Mr. Bias- yes and Mr. Riesterer-yes.

Trustees mentioned that Mr. Mike Conrad has offered to donate a light bar similar to the ones we currently use for the new truck. Also the trustees said the new truck and equipment would be paid out of our general fund.

Mr. Pooch moved, seconded by Mr. Bias to purchase 2 new Simplicity lawn mowers for our cemetery, with the trade in of our current mowers from Bill's Implement. Total cost of mowers after trade in will be \$2000. Vote: all ayes.

Mr. Tom Johnson had a brief zoning report. He asked about the Cody property and Mr. Riesterer said he would contact the Prosecutors Officer about it.

Chief Keimer gave his report. He will be gone from March 19 – April 8, 2011. The county started our dispatching March 1<sup>st</sup>. Tom has not heard anything on grants that he applied for.

The Park Board would like to replace their mower. They had a bid from Shearer Equipment for a John Deere tractor mower. Mr. Bias said the Park Board is making a list of items that will need to be checked regularly at the Parks for this spring and summer season.

Mr. Bias moved, seconded by Mr. Pooch to purchase a new John Deere tractor, loader & mower, from John Deere Co, through Shearer Equipment for a cost under state bid of \$5900/ after trade in, for use at the park. Vote: all ayes.

Mr. Riesterer plans to meet with Margaret Rudolph, Erie County Human resources next Wednesday at 2:30 concerning helping us with our replacing Chief Keimer due his upcoming retirement.

The trustees will hold a public hearing on our final appropriations at our next meeting: March 17, 2011 at 7 p.m.

The Erie County Township Association will be having a meeting at Vermillion Township on Thursday, March 10, 2011, starting at 7 p.m.

Mr. Bias moved, seconded by Mr. Pooch to adjourn. Vote: all ayes.
