Thomas Johnson gave a Zoning report. He said a deposition for issues for a pole barn build in Ridgewood subdivision has been pushed back to March.

Mr. Pooch moved, seconded by Mr. Bias to approve and pay Erie County Sheriff \$8406.43 for 2017 dispatching services. Vote: all ayes.

Trustees discussed issues with Bay Bridge drainage. Mr. Jack Meyers was working on a plan for this issue. With Mr. Meyers job being eliminated Mr. Riesterer will send a letter to the Erie County Commissioners asking that they continue to work on this issue for Bay Bridge.

Mr. Bias moved, seconded by Mr. Pooch to approve the purchase of a Stryker self-loading cot for a cost of \$45000. Vote: all ayes.

Mr. Pooch moved, seconded by Mr. Bias to adjourn. Vote: all ayes The meeting was adjourned at 2:45 p.m.
