

The Margareta Township Trustees met on April 21, 2016 at 7 p.m.

Present were Mr. Bias, Mr. Pooch and Mr. Riesterer.

Mr. Bias moved, seconded by Mr. Riesterer to accept the minutes from the April 7, 2016 meeting, as presented by Fiscal Officer Mary Ann Lindsley. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Bias to approve and sign warrants #15092-15126 and eft's that were presented by the Fiscal Officer for payment. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Riesterer to accept the financial reports that were submitted. Vote: all ayes.

The meeting opened with a public hearing on the proposed zoning map changes.

Mr. Riesterer moved, seconded by Mr. Bias to pass Resolution 2016-02 accepting the new zoning map for Margareta Township. Roll Call Vote: Mr. Bias- yes, Mr. Riesterer- yes and Mr. Pooch- yes.

Mr. Jim Neill gave his Road/Cemetery Report.

Jim had a proposal from Harts Tree Service for the Cemetery trees.

Summer help was discussed.

Equipment for the new truck was discussed.

Recycle day for batteries, appliances and 12 tires per resident will be held on Saturday June 11, 2016 from 8 am to noon.

Mr. Riesterer moved, seconded by Mr. Bias to hire Harts Tree Service for tree work in Venice and Castalia Cemeteries for \$140/hr. for 3 people, with the total cost to be up to \$4000. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Bias to purchase 2 benches and a waste can with lid from Barco Products for our scattering garden for a cost of \$2500. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Riesterer to hire Deck A New from Bellevue to stain the wood deck at the scattering garden for a cost of \$650.00. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Riesterer to pass Resolution 2016-03 approving the opening and closing agreement with Sand Hill Cemetery. Vote: Mr. Bias- yes, Mr. Riesterer- yes and Mr. Pooch- yes.

Mr. Keith Kreager from Crystal Rock and our Rural Water representative was in attendance.

Chief Johnson gave his Fire Department Report.

Chief mentioned holding training here for excel and the surface pro 360. He will get more information.

Building repairs were discussed.

The closure of Bardshar Rd for 4 months was also discussed.
