Mr. Pooch moved, seconded by Mr. Bias to appoint the following people to our record retention committee for 2012: Timothy Riesterer, Mary Ann Lindsley, Tom Johnson, Bill Mohr, Kevin Dwight, Barb Sessler and Brenda Ried, Vote: all ayes. Mr. Bias moved, seconded by Mr. Pooch to renew our annual contract with Dr

Schill for services as the Fire Department Medical Director from 1/1/2012 thru 12/31/2012, for a fee of \$5.00. Vote: all ayes.

This ended our organizational meeting.

Mr. Pooch moved, seconded by Mr. Bias to approve the minutes, as presented by Fiscal Officer, Mary Ann Lindsley, from the December 15, 2011 meeting. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Pooch to approve and sign warrants #11267-11339 that were presented for payments by the Fiscal Officer. Vote: all ayes.

Mr. Pooch moved, seconded by Mr. Bias to accept the financial reports that were presented by Fiscal Officer, Mary Ann Lindsley. Vote: all ayes.

Mr. Dave McGuckin was at the meeting regarding us going with Allstate for accident and cancer policies. He had already talked to employees about this and he wanted to have employees go with payroll deductions for these policies. After discussing this, the Trustees said we needed to check into it, since we already have a plan through Aflac that has a policy date of June. The Trustees said we would need to check into this before allowing anything new to be started.

Mr. Jim Johnson was at the meeting with a storm water update. He had sent in our 2011 report of our activities. Mr. Johnson said that he has about 95-98% of our storm water documents completed.

Mr. Tom Johnson gave a zoning update. He had been checking into the mow to own program. He said that you go through the County Prosecutors office to get the proper information. The Trustees said he should check with Jason at the prosecutor office to see what we can do. There is on issue with who owns the property in Crystal Rock that had a tree fall on a neighbor's house.

We received a note from Ed Pickard saying that the battery business is still being run in Crystal Rock. Mr. Pickard included a picture showing a sign in the window. Tom will check into it again.

Chief Mohr gave his report. The bid date has expired for the sale of unit 123. Our reserve was set at \$7500. The high bid was \$4000. The Trustees said they feel we should advertise it again and try to get more for it. Chief Mohr had a list of surplus equipment that we need to get rid of.

Chief Mohr presented a list of his bonus calls that showed he made at least 50%

of the total call, which according to his contract entitles him to receive a \$500 per quarter for the 3^{rd} and 4^{th} quarters of 2011.

Mr. Bias moved, seconded by Mr. Pooch to approve the inventory list of Fire Department surplus equipment. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Pooch to pay Wm Mohr \$500 per quarter for the 3^{rd} and 4^{th} quarters of 2011 for making at least 50% of the calls. Vote: all ayes.

Mr. Pooch moved, seconded by Mr. Bias to increase Wm Mohr's pay, per his contract, from \$59000 to \$61950, effective January 14, 2012. Vote: all ayes.

Also Trustees said that the full time firefighters will receive their raises per their contracts. Raises will be effective with pay period start date of December 31, 2011.

Mr. James Neill gave his report. He mentioned that there is a problem with water on McCartney Rd. He said that property owners approached him about getting a ditch petition for the ditch on McCartney. Mr. Neil! said he could clean a 150 ft of the ditch that he feels would help for now.

Newell Equipment is now working on our truck.

The underground storage tank is being removed tomorrow.

Our cemetery rates were discussed.

Communications were gone over.

Mr. Pooch moved, seconded by Mr. Bias to adjourn. Vote: all ayes. The meeting adjourned at 10 p.m.
