The Margaretta Township Trustees met in regular session on August 15, 2013.

Mr. Riesterer moved, seconded by Mr. Bias to approve the minutes that were presented by the Fiscal Officer for the August 1, 2013 meeting. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Riesterer to approve and sign warrants 12692-12726, that were presented for payment by the Fiscal Officer. Vote: all ayes.

Mr. Jim Neill gave his Road/Cemetery report.

The purchase of a new pickup truck was discussed. Jim suggested getting a 2014 F-250 4 WD from Mathews Ford.

Jim said he was working on the Issue II Phase II Old Railroad Resurfacing paperwork. The paperwork is due September 6, 2013.

We put together a cost/maintenance report for the Cemetery Fund, showing income and expenses. The trustees said we break even now. This depends on lots sold and the number of burials per year.

It was mentioned that Chuck Gasser, Homegardner Road called about his driveway settling. Mr.

Riesterer said he had looked at it and he didn't think it looked that bad.

Fiscal Officer, Mary Ann mentioned that we received \$3750 for our tire grant. She also mentioned her concern with the expenses for the Road Department. She said she'll wait until our next meeting to see how our funds look to try to see where we can pay expenses from.

Mr. Riesterer moved, seconded by Mr. Bias to purchase a F250 Ford 4 WD with the tow package from Mathew Ford for a cost of \$23,500. Vote: all ayes. This purchase will be paid with general fund money.

Mr. Tom Johnson gave a zoning report. He talked to Scott Schell of the land bank. For anything to go to the land bank it needs to be a foreclosure or sheriff sale property.

Mr. Johnson also asked that we get an updated list of our zoning board members.

Chief Mohr gave his fire department report. He said that the association would like to spend the additional money toward a 60" plus TV for the lam responding Program. The TV could also be used for social events and fire prevention activities.

Matt Stacy will be attending EMT school this fall.

Chief mentioned that the Hurst pump on unit 121 has been repaired for \$400.

Chief Mohr said that the target date for the new software for dispatch is 2014.

Next week will be the ribbon cutting for the new overpass. Then Venice Road will be closed for a few weeks for their tie in to the overpass.

Mr. Bias moved, seconded by Mr. Riesterer to approve the vacation request of Mike Jesbergerer for September 11, & 16, 2013 and for Dean Gasser for September 21, 2013. Vote: all ayes.

Mr. Keith Kreager of Crystal Rock asked if there were any water issues. There were none. He also mentioned that some stone is needed on Crystal Rock Road and Bayshore where the bus turns around.

The trustees mentioned that the CGBG Grant was approved by the State for our handicap accessibility for our building on Main Street in the amount of \$23,000.

The trustees said that we should bill the Village of Castalia for the rental of the generator for the lights for the Flags during the Cold Creek Festival.

Mr. Riesterer moved, seconded by Mr. Bias to adjourn. Vote: all ayes. The meeting adjourned at 8:50 p.m.
