

The Margaretta Township Trustees met in regular session on June 4, 2015 at 7 p.m.

Present were Mr. Bias, Mr. Pooch and Mr. Riesterer.

Mr. Riesterer moved, seconded by Mr. Pooch to approve the minutes from the May 21, 2015 meeting, as presented by Fiscal Officer, Mary Ann Lindsley. Vote: all ayes.

Mr. Pooch moved, seconded by Mr. Riesterer to approve and sign warrants #14275-14316 and direct deposits that were submitted for payment by the Fiscal Officer. Vote: all ayes

Mr. Riesterer moved, seconded by Mr. Pooch to accept the financial reports that were presented by the Fiscal Officer. Vote: all ayes.

Mr. Kevin Lindsley our Health Insurance Agent was at the meeting to go over our Medical Mutual renewal. Mr. Lindsley also presented other quotes he had received. After a brief discussion the following motion was made.

Mr. Riesterer moved, seconded by Mr. Pooch to continue our health insurance coverage with Medical Mutual of Ohio effective July 1, 2015. Vote: all ayes.

Mr. Jim Neill gave his Road/Cemetery Report.

Jim mentioned that a maple tree in front of Graves Cemetery needs to be cut down. It is too bad to keep. There will be an additional \$1500-\$2000 cost involved.

Jim said the road mowing is about 50% done. We sprayed Sand Hill for weeds.

Chief Johnson gave a Fire Dept. report.

Chief mentioned that he went to the meeting with Bay View. No decisions were made on how we will handle the calls we make there.

We may open a Sam's Club account again. Chief Johnson would like to purchase a Surface Pro 3 and possibly some other items there.

Chief Johnson mentioned that Robert Street has moved to a Class B Firefighter.

Mr. Pooch moved, seconded by Mr. Riesterer to declare surplus equipment as scrap after attempts to sell on Gov. deals and e-bay were unsuccessful. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Pooch to rehire Sandi Martin as a part time seasonal worker effective 6/8/2015 and to increase here wage from \$10/hour to \$10.25/hour. Vote: all ayes.

The trustees mentioned that any upcoming levies must be filed by August 5, 2015. The trustees discussed possibly putting a new 2 mill levy on for Fire and if it passes we will drop the 2 1 mill levies. Mr. Bias will check into this possibility.

Mr. Riesterer moved, seconded by Mr. Pooch to move our seconded meeting in July to July 23, 2015. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Pooch to pay Chief Johnson a salary of \$60,000 (\$2307.70 per pay period) effective May 30, 2015 and keep Chief Johnson as interim Chief until December 31, 2015. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Pooch to offer John Secue a full time position with the Fire Department effective possibly June 27, 2015. Vote: all ayes.

Mr. Pooch moved, seconded by Mr. Riesterer to adjourn. Vote: all ayes.
