The Margaretta Township Trustees met on December 19, 2019 at 7:00 PM

Present were Mr. Pooch, Mr. Riesterer, and Mr. Bias. The pledge of allegiance was recited.

Mr. Riesterer moved, seconded by Mr. Pooch to approve the minutes from the December 5, 2019 meeting as presented by Fiscal Officer Robert Day. Vote: all ayes

Mr. Riesterer moved, seconded by Mr. Pooch to approve and sign the warrants (18309 –18361) and EFTs submitted for payment by the Fiscal Officer. Vote: all ayes

Mr. Riesterer moved, seconded by Mr. Pooch to approve the financial reports submitted by the Fiscal Officer. Vote: all ayes

Jim Johnson, 50/50 Water:

Mr. Johnson reported that the Storm Water Requirements for 2019 have been completed along with the annual inspection.

Mr. Johnson discussed the Storm Water Pollution Prevention Plan for 2020 and indicated he will write the plan for the Township.

Mr. Bias provided an update on the union negotiations. The Union will submit their final proposal in January.


