Mr. Pooch moved, seconded by Mr. Riesterer to reappoint the following people to the Records Retention Committee for 2013: Timothy Riesterer, Mary Ann Lindsley, Barb Sessler, Brenda Ried, Thomas Johnson and Wm Mohr. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Pooch to renew an annual contract with Dr. Schill for services as the Fire Department Medical Director from 1/1/2013 through 12/31/2013 for a fee of \$5. Vote: all ayes.

Mr. Pooch moved, seconded by Mr. Riesterer to allow the Trustees and Fiscal Officer to be included in all of the Township medical/life insurance plans or to be compensated for the cost of medical insurance to the elected official for a cost not to exceed the cost of the township policy.
