Mr. Tom Johnson gave his zoning report. He said he is working on the Hensley property.

Chief Mohr gave his report. He discussed his concern with Bay View responses to their calls. He had a list of items he would like to get rid of as surplus items: 2 bottle fill station, 4500 lb air bottles, and a mecco compressor. We have received our new compressor due to a FEMA Grant. Chief Mohr said he had applies for another grant. There was a discussion on vacation pay. According to the trustees when an employee's anniversary gives that employee an additional week of vacation the extra week will begin the following year. Chief said he would be attending an Ohio Fire EMS Class in Columbus on September 20 & 21, 2012.

Mr. Pooch moved, seconded by Mr. Riesterer to pass Resolution 2012-06 approving the sale of our old ambulance for \$15,000 to Put In Bay. Roll Call Vote: Mr. Riesterer –yes, Mr. Pooch-yes and Mr. Bias-yes.

Mr. Riesterer moved, seconded by Mr. Pooch to grant Mike Jesberger and Keith Killingsworth their training request for October 4-8, 2012 in Bowling Green at a cost of \$445/each (\$890 total) for Basic & Intermediate Rope Rescue Class. They will also have the use of a vehicle if needed. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Pooch to declare the following as surplus items, due to the purchase of a new compressor: bottle refill station, 6 4500lb air bottles, and 1 mecco compressor, with the sale to be handled by Chief Mohr and the money going into the Fire Fund. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Pooch to go into executive session to discuss matters confidential by law. Roll Call Vote: Mr. Riesterer-yes, Mr. Pooch-yes and Mr. Bias-yes.

Mr. Riesterer moved, seconded by Mr. Pooch to return to regular session. Roll Call Vote: Mr. Riesterer-yes, Mr. Pooch-yes and Mr. Bias —yes.

Mr. Riesterer moved, seconded by Mr. Pooch to pay Chief Mohr a call back bonus of \$750 for the first half of 2012 and \$1239 retention bonus, as per his contract, for a total of \$1989. This will terminate his current contract. Vote: all ayes

Mr. Riesterer moved, seconded by Mr. Pooch to increase Chief Mohr's salary to \$65,189 effective September 8, 2012. Vote: all ayes. This will set Chief Mohr's pay at \$2507.27 every two weeks.

Mr. Riesterer moved, seconded by Mr. Pooch to pass resolution 2012-07 accepting the amounts and rates as determined by the Budget Commission of Erie County for 2013. Roll Call vote: Mr. Riesterer – yes , Mr. Pooch- yes and Mr. Bias- yes.

Fiscal Officer, Mary Ann, mentioned that she had contacted the person that was doing our audit since she hadn't heard from her in several weeks. The auditor said she had turned everything over to her boss. So we're not sure what's going on.

Also the State UAN system is going to have all new software for the beginning of 2013 and the Fiscal Officer's will have to do training in both accounting and payroll before they are issued the new software. This training will need to be done by the end of the year.

Correspondence was gone over.

Mr. Pooch moved, seconded by Mr. Riesterer to adjourn. Vote: all ayes.
