Mr. Jim Johnson gave a storm water update. There will be a meeting with Crystal Diamond on November 6, 2012 regarding zoning with Jim Johnson and Tom Johnson and zoning board members that attend.

Chief William Mohr gave his Fire Department report. Bill has a list of surplus radio equipment that he would like to get rid of. Chief Mohr mentioned that Unit 124 is in the shop and needs new tires. Chief Mohr is getting a quote from Verizon for all of our township cell phones. It looks like we should be able to save on the new plan. Our concern is service here in our building.

Mr. Riesterer moved, seconded by Mr. Pooch to declare radio equipment as surplus and put it on gov.deal to get rid of. Vote: all ayes.

Mr. Pooch moved, seconded by Mr. Riesterer to purchase 4 new tires for Unit 124 for a cost not to exceed \$2300.00. Vote: all ayes.

Mr. Tom Johnson gave his zoning report. Mr. Johnson has been working on several issues. He is working on issues in Crystal Rock, property off SR 101 and issues with property off Maple Ave.

Mr. Jim Neill gave his road/cemetery reports. Jim put an order in for 250 ton of salt from ODOT at a cost of \$38.20 ton. He said he estimates that repairs to the cemetery drive will be around \$1000. Jim also mentioned that Brenda is working on new cemetery rates.

Mr. Riesterer moved, seconded by Mr. Pooch to pay for photos of the township from American Images for \$920. Vote: all ayes.

Mr. Keith Kreager came to the meeting. He represents us to Rural Water. He said there are over 11,000 customers now getting Rural Water. Keith also mentioned Crystal Rock. He said he feels that the properties are looking pretty good as far as he is concerned.

The trustees said we will not be having a fall leaf drop off this year due to low funds in our Road Fund.

The trustees discussed levies. They said we need to put on a new levy for the Road Department on the ballot next year. The Road Dept isn't bringing in enough to cover their expenses.

The trustees said that the Spooner group said they feel they may be able to get some of our workers comp premiums back from past years.

The Townships are on the agenda for the November 12, 2012 meeting of the Erie County Commissioners to discuss the county gambling dollar distribution.

The Council of Government meeting will be on October 29, 2012. Mr. Riesterer will be attending.

Fiscal Officer, Mary Ann Lindsley, said we still have heard nothing about our audit.
