The Margaretta Township Trustees met on March 7, 2013 at 7 p.m.

Present were Trustees: Mr. Riesterer, Mr. Bias and Mr. Pooch

Mr. Bias moved, seconded by Mr. Riesterer to accept the minutes from the February 21, 2013 meeting that were presented by Fiscal Officer, Mary Ann Lindsley. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Bias to approve and sign warrants #12320-12357 that were presented for payment by the fiscal officer. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Riesterer to accept the financial reports submitted by the fiscal officer. Vote: all ayes.

The meeting began with a public hearing on our proposed 2013 final appropriations. After looking over the proposed appropriations and having a brief discussion the following motion was made:

Mr. Bias moved, seconded by Mr. Riesterer to approve the proposed appropriations and to submit our final appropriations to the county auditor. Vote: all ayes.

Mrs. Jane Ann Williams was at the meeting representing the Thomas Neill Women's Relief Corp. She discussed Memorial Day and Mr. Bias agreed to speak at the Veterans Memorial. Mrs. Williams also mentioned that they are hosting Ohio Flags of Honor Memorial, July 19-21, 2013. There will be 279 flags placed near our Veteran Memorial, to represent deceased military men from Ohio. The event will kick off on July 19, 2013 at 5 p.m. Mrs. Williams is asking for help with the PA system and lighting. The trustees said they would be willing to help, but they would like to split the cost with the Village of Castalia. Mrs. Williams said she will be getting in touch with the Village.

Mr. Keith Kreager from Crystal Rock and our Rural Water representative was at the meeting. He mentioned that Rural Water is giving a \$1000 discount for anyone who taps in to Rural Water and that already has a line going across their property. This discount is good through March 2013.

Mr. Tom Johnson gave a zoning report. He mentioned a lawsuit filed regarding a property dispute on Maple Ave. This has nothing to do with us. It's a property owner dispute. Tommy mentioned that our public hearing on the Hensley property will be on March 21, 2013 at 7 p.m. Notices have gone out for this hearing.

Mr. Jim Johnson gave a storm water update. He went over some questions on the annual report with the trustees. He will fill out and submit our report.

Verizon has started constructing their tower on Lucas St. We should start getting our payments beginning March 1, 2013. The annual payment will be \$8700/ and will be paid monthly.

Mr. Jim Neill gave his report. He gave the trustees his road maintenance proposal. The approximate cost will be \$149,026.

Mr. Riesterer moved, seconded by Mr. Bias to approve the road department inventory and maintenance proposal for 2013. The approximate cost for road maintenance is \$149,026. Vote: all ayes

Trustees mentioned that there will be a webinar on March 15, 2013 at 10 a.m. regarding the sign grant.

The trustees also said that we will begin getting rid of the records that have been approved to be destroyed.

Chief Mohr gave his report. He mentioned that they would like to purchase a new 2013 GMC Sierra Crew Cab, ½ ton, 4x4 pickup truck, under the state bid, for the Fire Department from Bob Ross Buick, Inc for a cost of \$25,819. We will sell our current truck after getting the new one.

Mr. Riesterer moved, seconded by Mr. Bias to purchase a new4x4 pickup truck under state bid, per quote from Bob Ross Buick Inc. for a cost of \$25,819. Vote: all ayes

Mr. Bias moved, seconded by Mr. Riesterer to add extras to the pickup truck for a cost not to exceed \$4000. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Bias to declare 5 old computers as surplus and donate them to Goodwill. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Bias to approve the contract for EMS services between Margaretta Township and Rockwell Springs Trout Club. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Bias to spend up to \$2000 to Horton to install safety chevrons on Unit 112. Vote: all ayes.

Mr. Riesterer moved, seconded by Mr. Bias to approve the commencement date of March 1, 2013 for the agreement with Verizon. Vote: all ayes.

The Park Board is getting ready to award a contract for the operation of the concession stands. They are also going to get quotes for the sealing of the parking lot and drive. They will also include the sealing of the cemetery drive.

Fiscal Officer, Mary Ann mentioned that we had been given a credit on our workers comp, but that they had taken the credit away. According to Andy Frank of Frank Gates there was some misunderstanding since we had signed paperwork with two companies to represent us. We signed a form to be sent to Frank Gates. Andy said he will try to get this credit reapplied so we can take it when paying our premium.

Mr. Riesterer moved, seconded by Mr. Bias to approve our contract with the Erie County Sheriff for dispatch services from May 1, 2013 through April 30, 2014, for \$8000/year. Vote: all ayes.

Mr. Bias moved, seconded by Mr. Riesterer to adjourn. Vote: all ayes.
